Signs and Symptoms of Exposure – Irritation or burning sensation. Medical Conditions Generally Aggravated by Exposure – May aggravate skin disorders or respiratory ailments.

SECTION VII – PRECAUTIONS FOR SAFE HANDLING AND USE

Steps to be Taken in Case Material is Released or Spilled – Wear appropriate protective equipment. If possible, contain spill and collect in approved container. Rinse affected area thoroughly with water. Keep product out of storm sewers or waterways. Hold for disposal.

Waste Disposal Method – Dispose of in accordance with local, state and federal regulations. If possible, triple rinse container, and recycle.

Precautions to be Taken in Handling and Storing – Avoid contact with skin or eyes. Avoid breathing vapor, spray or mist. Store in original container, in cool dry place with adequate ventilation. Keep out of reach of children. Keep container tightly closed when not in use.
